

Good Neighbours Charter

MVV Baldovie Environment Limited and the Community

This Charter will be agreed and protects the principles of a good neighbour agreement. The Charter will aim towards best practice in good neighbour agreements.

The Good Neighbours Group will form a structure for communication between MVV Environment Baldovie and the Community.

Good Neighbours Group

MVV Environment Baldovie agrees to the continuation of a Good Neighbours Group.

The Good Neighbours Group will meet every four months, with a provision for additional meetings if required.

Information, as detailed below, will be shared with the Good Neighbours Group at the Good Neighbours meetings.

The Charter will be reviewed every two years.

Minutes

Minutes of the meetings will be published on the MVV Environment Baldovie website and a link to MVV Environment Baldovie website will be available on the Dundee City Council's website.

Open Access to Visit the Facility

Community members of the Good Neighbours Group are welcome to visit the facility by prior arrangement and accompanied by independent experts of their choice, by mutual agreement. Other community groups may also visit the facility by prior arrangement.

Accident Emergency Plans

MVV Environment Baldovie's procedures for dealing with emergencies or accidents likely to affect local communities will be shared with the members of the Good Neighbours Group.

Environmental Performance

- Information of Environmental Performance will be shared with the Good Neighbours Group
- Technical reports on emissions will be shared with the Good Neighbours Group
- Where emission limits are exceeded a full explanation of the cause, and measures taken as a result, will be shared with the Good Neighbours Group
- All other data is reported to SEPA and is available on public request.

Employment Policies

- MVV Environment Baldovie will abide by all legal requirements in employment practice, including those relating to trade union recognition
- MVV Environment Baldovie will seek to employ local people who meet the requirements for the post
- An update on any staffing changes will be shared with the Good Neighbours Group

Good Neighbours Charter

Local Economic Conditions

- When procuring goods and services, MVV Environment Baldovie will discuss matters of mutual interest with the Good Neighbours Group
- MVV Environment Baldovie will prioritise suitably qualified and experienced local companies who can fulfil their requirements

Transportation of Waste

- MVV Environment Baldovie will work with partners to ensure that conforming waste is delivered to the plant
- MVV Environment Baldovie will work with partners to ensure waste delivery routes are designed to take account of local schools and other relevant factors

Changes to Operating Conditions

- MVV Environment Baldovie will share any relevant changes in environmental or other legislation with the Good Neighbours Group
- MVV Environment Baldovie will share any proposed changes to the Environmental Permit (PPC/A/1003157) with the Good Neighbours Group
